General Information

Fresh South, Inc. is a 501 3 C non-profit organization, which leases the land from Peachtree City. Its all-volunteer board manages the community garden.

Plots are rented on an annual basis, with reservation for the 2020 planting year, beginning Sept. 1, 2019. A nonrefundable deposit of \$20 is due with registration or payment in full would also be accepted. Plots will be assigned on a first come first serve basis, rental balance will be due within 14 days of receiving plot assignment. (Plot assignment will not take place until after plots are installed)

Membership fees:

8x20 plot \$100.00

[Only returning gardeners may rent a 2nd plot...fee will be \$80.00]

8x10 [1/2 plot] \$ 60.00

Monies collected are to be used for insurance, city fees, general maintenance of the garden, administrative expenses, tools, repairs, utilities, promotional and marketing expenses, educational programs and capital improvements.

Only organic/natural pesticides and fertilizers will be used by gardeners and are supplied by the individual gardener. Vegetable transplants or seeds are provided by gardener. (No trees, mint or invasive plants are allowed)

Rules

1. Each gardener is responsible for the maintenance and upkeep of their garden plot and immediate plot area. Watering, weeding, harvesting and any other garden related maintenance are all the responsibility of the gardener. Gardeners may arrange for other gardeners to tend/water their plots.
2. For safety and maintenance purposes, all aisles need to be kept clear. (Example: no tomato cages, trellises, poles etc.) Nothing shall be grown on the garden fence. Community tools will be returned to the shed for storage and cleaned of debris.
3. Always monitor when watering the garden. Never leave the water on.
4. Children are welcome in the community garden but must be accompanied by an adult and must be supervised at all times.
5. If a group or individual must abandon their plot for any reason, they will notify the board via email: **ptccommunitygardens@gmail.com**.
6. **Unattended gardens may be reassigned or covered by the board.** (Examples of unattended gardens are excessive weeds, rotting produce.)
7. No animals are allowed within the fenced area.
8. ALWAYS lock the gate and shed after leaving.
9. No nails, screws etc. are to be inserted into the plastic lumber sides of garden plots.

Please be mindful that this is a shared space.
